I want everyone I work with to feel safe at all times, and I am committed to building an inclusive, intersectional business. This includes but is not limited to race, sexuality, gender, (dis)ability including physical and mental health, neurodiversity, religion, parenthood and those with caring responsibilities. Any discrimination of any sort will not be tolerated.

The Rebel Rousers, and by association, The Joyful Rebellion Season Pass, is built upon shared values of mutual respect, kindness and inclusivity.

By joining The Joyful Rebellion Season Pass, you are acknowledging these values, and understand that any violation will result in the immediate termination of your participation and a pro-rata refund will be given.



I want to make sure that we're both clear about our responsibilities and expectations during our time together. I've outlined these in the Coaching Agreement below.

## **COACHING AGREEMENT**

### Coaching relationship

This is a coaching relationship. You are in the driver's seat of your life. Feel free to dismiss anything I say. This is a coaching relationship, and at no point, is or will become any type of therapy or psychological counselling. Please bring any issues relating to this to my attention.

### Confidentiality

I will treat everything that is discussed in strict confidentiality. The only time I will breach this is if I think you or someone else is at risk of harm.

## Conflicts/Disagreements

This is an open relationship and I encourage you to be honest with me from the start. Please let me know if you'd prefer me to do something in a different way or if I have said something to upset you so we can work it out.

## Coaching Contract

This agreement is between you and coach Meg Kissack.

## Services

The service provided will be The Joyful Rebellion Season Pass, an online group coach programme. The standard fee for this programme is £220. to be paid upfront before starting in June, or via 4 monthly payment plans of £55. If you have chosen to pay via payment plan, this is committing to pay the total amount.

All payments are final, but if your circumstances do change, please do get in touch and we might be able to sort something out.

The Joyful Rebellion Season Pass will take place between June 10th 2023 - September 10th 2023 and will include:

- A Joyful Rebellion hub to easily access replays and resources.
- A Whatsapp group
- Lifetime access to The Rebel Social
- Anything else I create between June 10th 2023, and September 10th 2023 (excluding 1:1 coaching, One Woman Band Club/ Rebel Creators and physical products.)



Coaching may address specific personal projects, business successes, or general conditions in the client's life or profession. Other coaching services include value clarification,

brainstorming, identifying plans of action, examining modes of operating in life, asking clarifying questions, and making empowering requests or suggestions for action. Throughout the working relationship, the coach will engage in direct and personal conversations. The client understands that successful coaching requires a co-active collaborative approach between client and coach. In the coaching relationship, the coach plays the role of a facilitator of change, but it is the client's responsibility to enact or bring about the change.

If the client believes the coaching is not working as desired, the client will communicate this to the coach, and this will be discussed in a professional and constructive manner. You have the right to leave The Joyful Rebellion Season Pass at any time.

### Prior History

As a coach, I do not engage in therapy with my coaching clients. In entering into the coaching relationship, and signing the agreement, you are agreeing that if any mental health difficulties arise during the course of the coaching relationship, you will notify me immediately so that I can discuss with you an appropriate referral.

### Privacy

The client can, at any point in any coaching session, declare their preference not to discuss a specific issue, by simply stating that

they would rather not discuss this issue. The coach agrees to respect this boundary and will not attempt to forward the conversation further along those lines.

## Confidentiality

Everything in the calls, the Whatsapp group and any other communication with the other members is shared in the understanding of strict confidentiality. Anything shared by other members of the group of yourself will be held in the strictest of confidence and each member is required to sign this agreement before joining The Joyful Rebellion Season Pass. The only time I will breach this is if I think you or someone else is at risk of harm.

All calls, except for the Get Shit Done Days, will be recorded, but only shared within the group for people to catch replays when they're not available to make the calls live. These calls will be housed in our secure The Joyful Rebellion Season Pass dashboard. The two workshops included in the Season Pass will be available for external purchase, so the workshop replays will be available for people who booked on.

As a client, I understand and agree that I am fully responsible for my well being during my coaching, including my choices and decisions. I am aware that I can choose to discontinue coaching at any time. I recognise that coaching is not psychotherapy and that professional referrals will be given if needed. I also accept

that if my coach suspects that I or someone I know could be in a harmful situation my coach can contact the police and the client confidentiality clause will be null and void.

# CODE OF ETHICS

While I am not an ICF certified coach, I have adapted their code of ethics for this coaching relationship.

## Code of Ethics

### Part One: Definition of Coaching

#### Section 1: Definitions

- Coaching: Coaching is partnering with clients in a thought provoking and creative process that inspires them to maximize their personal and professional potential
- A professional coaching relationship: A professional coaching relationship exists when coaching includes a business agreement or contract that defines the responsibilities of each party.
- Client: The "client" is the person(s) being coached.

#### Section 2: Professional Conduct At Large

As a coach:

- 1) I will not knowingly make any public statement that is untrue or



misleading about what I offer as a coach or make false claims in any

written documents relating to the coaching profession or my credentials

### Code of ethics

2) I will accurately identify my coaching qualifications, expertise, experience, and certifications

3) I will recognize and honor the efforts and contributions of others and not misrepresent them as my own. I understand that violating this standard may leave me subject to legal remedy by a third party.

4) I will, at all times, strive to recognize personal issues that may impair, conflict or interfere with my coaching performance or my professional coaching relationships. Whenever the facts and circumstances necessitate, I will promptly seek professional assistance and determine the action to be taken, including whether it is appropriate to suspend or terminate my coaching relationship(s).

5) I will maintain, store, and dispose of any records created during my coaching business in a manner that meets regulations.

## Section 2: Professional Conduct with Clients

As a coach:

6) I will not knowingly mislead or make false claims about what my client or sponsor will receive from the coaching process or from me as the coach.

7) I will not give my prospective clients or sponsors information or advice I know or believe to be misleading or false.

8) I will have clear agreements or contracts with my clients. I will honour all agreements or contracts made in the context of professional coaching relationships.

9) I will carefully explain and strive to ensure that, prior to or at the initial meeting, my coaching client and sponsor(s) understand the nature of coaching, the nature and limits of confidentiality, financial arrangements, and any other terms of the coaching agreement or contract.

10) I will be responsible for setting clear, appropriate, and culturally sensitive boundaries that govern any physical contact I may have with my clients or sponsors.

11) I will not become sexually intimate with any of my current clients or sponsors.

12) I will respect the client's right to terminate the coaching relationship at any point during the process, subject to the provisions of the agreement or contract. I will be alert to

indications that the client is no longer benefiting from our coaching relationship.

13) I will encourage the client to make a change if I believe the client would be better served by another coach or by another resource.

14) I will suggest my client seek the services of other professionals when deemed necessary or appropriate.

#### Section 4: Confidentiality/Privacy

As a coach:

15) I will maintain the strictest levels of confidentiality with all client and sponsor information. I will have a clear agreement or contract before releasing information to another person, unless required by law.

16) I will have a clear agreement upon how coaching information will be exchanged among coach and client.
